

## DEMOCRATIC ACTION PARTY-KENYA ASPIRANT CODE OF CONDUCT – 2025

As an aspirant seeking nomination to contest for political office under the **Democratic Action Party-Kenya (DAP-K)** I hereby commit myself to uphold the highest standards of integrity, discipline, and respect for the democratic values of the Party and the nation.

### 1. Loyalty to the Party

I shall abide by the Constitution, rules, and regulations of Democratic Action Party-Kenya.

I shall promote the vision, mission, and values of the Party at all times.

I shall accept and respect the Party's decisions on nominations, dispute resolution, and related processes.

### 2. Integrity and Accountability

I shall conduct myself with honesty, transparency, and accountability.

I shall not engage in corruption, bribery, or any unlawful practices.

I shall make full disclosure of any matter that may affect my credibility or eligibility as an aspirant.

### 3. Peaceful Conduct

I shall not engage in or incite violence, hate speech, intimidation, or harassment against fellow aspirants, party members, or the public.

I shall ensure that my supporters maintain peace and order during campaigns, meetings, and electioneering activities.

### 4. Respect for Opponents and Party Members

I shall respect the rights of other aspirants to seek nomination and shall not malign, defame, or unduly interfere with their campaigns.

I shall resolve any disputes through the Party's established internal mechanisms.

I shall respect party leaders, officials, and institutions.

### 5. Compliance with Electoral Laws

I shall comply with all national electoral laws, regulations, and guidelines as issued by the Independent Elections and Boundaries Commission.

I shall not engage in voter bribery, multiple registrations, or any other electoral malpractice.

## 6. Responsible Campaigning

I shall avoid divisive politics based on ethnicity, religion, gender, or any form of discrimination.
